2024 CFA EXAM SCHEDULE OVERVIEW

THE 2024 CFA EXAM DATES ARE STRUCTURED TO OFFER CANDIDATES MULTIPLE OPPORTUNITIES TO TAKE EACH LEVEL THROUGHOUT THE YEAR. THE CFA INSTITUTE TYPICALLY SCHEDULES EXAMS FOR LEVELS I, II, AND III DURING SPECIFIC MONTHS, WITH SOME FLEXIBILITY FOR LEVEL I THROUGH COMPUTER-BASED TESTING. UNDERSTANDING THE SCHEDULE ALLOWS CANDIDATES TO SELECT THE MOST SUITABLE EXAM WINDOW ACCORDING TO THEIR READINESS AND PERSONAL COMMITMENTS.

LEVEL I EXAM DATES

LEVEL I OF THE CFA EXAM IS OFFERED SEVERAL TIMES IN 2024, REFLECTING THE SHIFT TO COMPUTER-BASED TESTING THAT ALLOWS GREATER FLEXIBILITY. LEVEL III EXAM DATES

REGISTRATION DEADLINES AND FEES

EARLY REGISTRATION

- EARLY REGISTRATION DEADLINE: VARIES, OFTEN 6 MONTHS BEFORE EXAM
- STANDARD REGISTRATION DEADLINE: APPROXIMATELY 3 MONTHS BEFORE EXAM
- LATE REGISTRATION DEADLINE: UP TO 1 MONTH BEFORE EXAM, IF AVAILABLE
- FEE DIFFERENCES CAN EXCEED SEVERAL HUNDRED DOLLARS BETWEEN EARLY AND LATE REGISTRATION

EXAM FORMATS AND TESTING WINDOWS

THE 2024 CFA EXAM DATES CORRESPOND TO THE CFA INSTITUTE'S COMPUTER-BASED TESTING FORMAT, WHICH HAS REPLACED PAPER-BASED EXAMS. THIS MODERNIZATION ALLOWS CANDIDATES TO TAKE EXAMS AT AUTHORIZED CENTERS WORLDWIDE WITH INCREASED FLEXIBILITY AND SECURITY.

COMPUTER-BASED TESTING STRUCTURE

THE COMPUTER-BASED FORMAT ALLOWS CANDIDATES TO SELECT APPOINTMENTS DURING THE DESIGNATED TESTING WINDOWS, TYPICALLY SPREAD OVER SEVERAL DAYS OR WEEKS.

AVAILABLE TESTING WINDOWS IN 2024

THE TESTING WINDOWS FOR EACH CFA LEVEL IN 2024 ARE DESIGNED TO ACCOMMODATE DIVERSE CANDIDATE SCHEDULES AND GLOBAL TIME ZONES. CANDIDATES MUST BOOK THEIR EXAM APPOINTMENTS WITHIN THESE WINDOWS TO SECURE THEIR PREFERRED DATE AND TIME.

- LEVEL I TESTING WINDOWS: FEBRUARY, MAY, AUGUST, NOVEMBER
- LEVEL II TESTING WINDOWS: MAY AND AUGUST
- LEVEL III TESTING WINDOWS: MAY, WITH POSSIBLE NOVEMBER SESSION

PREPARATION TIPS BASED ON EXAM DATES
