- BECOMING A MEMBER OF PROFESSIONAL ASSOCIATIONS CAN PROVIDE ACCESS TO RESOURCES, NETWORKING OPPORTUNITIES, AND CONTINUING EDUCATION.

3. STAY INFORMED

- CONTINUOUSLY UPDATE YOUR SKILLS AND KNOWLEDGE BY ATTENDING WORKSHOPS, WEBINARS, AND CONFERENCES IN THE FIELD.

4. SPECIALIZE

- CONSIDER PURSUING ADDITIONAL TRAINING IN SPECIALIZED AREAS, SUCH AS LEGAL OR MEDICAL INTERPRETATION, TO ENHANCE YOUR EMPLOYABILITY.
