UNDERSTANDING THIS FORMAT IS KEY TO FOCUSING YOUR STUDY ON THE TYPES OF QUESTIONS YOU WILL ENCOUNTER.

STEP 2: CREATE A STUDY SCHEDULE

DEVELOPING A STUDY SCHEDULE IS ESSENTIAL FOR EFFECTIVE PREPARATION. A WELL-STRUCTURED PLAN ENABLES YOU TO BREAK DOWN THE VAST CONTENT INTO MANAGEABLE SECTIONS AND KEEPS YOU ORGANIZED.

HOW TO CREATE A STUDY SCHEDULE

4. **INCORPORATE REVIEW SESSIONS:** REGULARLY SCHEDULED REVIEW SESSIONS WILL HELP REINFORCE YOUR KNOWLEDGE AND IDENTIFY AREAS THAT REQUIRE ADDITIONAL FOCUS.

5. **PRACTICE QUESTIONS:** INCLUDE PRACTICE QUESTIONS IN YOUR SCHEDULE. AIM TO ANSWER AT LEAST 10-15 QUESTIONS FROM EACH TOPIC PER WEEK.

STEP 3: UTILIZE QUALITY STUDY MATERIALS

3. CIVIL LIBERTIES VS. CIVIL RIGHTS: DIFFERENTIATE BETWEEN CIVIL LIBERTIES (PROTECTIONS AGAINST GOVERNMENT ACTIONS) AND CIVIL RIGHTS (THE RIGHTS OF INDIVIDUALS TO RECEIVE EQUAL TREATMENT).

4. POLITICAL IDEOLOGIES: KNOW THE SPECTRUM OF POLITICAL IDEOLOGIES, INCLUDING LIBERALISM, CONSERVATISM, AND LIBERTARIANISM, AND HOW THEY INFLUENCE POLICYMAKING.

5. MAJOR SUPREME COURT CASES: FAMILIARIZE YOURSELF WITH LANDMARK SUPREME COURT CASES SUCH AS MARBURY V. MADISON, BROWN V. BOARD OF EDUCATION, AND ROE V. WADE. UNDERSTANDING THEIR CONTEXT, RULINGS, AND IMPLICATIONS IS CRUCIAL.

TERMINOLOGY TO KNOW

- BICAMERAL LEGISLATURE
- ELECTORAL COLLEGE
- POLITICAL ACTION COMMITTEES (PACs)
- JUDICIAL REVIEW

CREATE A GLOSSARY OF ESSENTIAL TERMS AND REGULARLY REVIEW THEM TO SOLIDIFY YOUR UNDERSTANDING AND RECALL ON TEST DAY.

STEP 5: PRACTICE, PRACTICE, PRACTICE

4. WRITING PRACTICE ESSAYS: FOR THE FREE RESPONSE SECTION, PRACTICE WRITING ESSAYS UNDER TIMED CONDITIONS. FOCUS ON STRUCTURING YOUR ESSAYS CLEARLY, USING RELEVANT EXAMPLES, AND ARTICULATING YOUR ARGUMENTS EFFECTIVELY.

5. SEEK FEEDBACK: IF POSSIBLE, SEEK FEEDBACK ON YOUR PRACTICE ESSAYS FROM TEACHERS OR PEERS. CONSTRUCTIVE CRITICISM CAN HELP IMPROVE YOUR WRITING AND ANALYTICAL SKILLS.

BY INCORPORATING THESE PRACTICE STRATEGIES INTO YOUR STUDY ROUTINE, YOU WILL ENHANCE YOUR CONFIDENCE AND PERFORMANCE ON THE EXAM.
