SYMBOLISM

STEVENSON UTILIZES SYMBOLISM TO CONVEY DEEPER MEANINGS. THE POTION THAT TRANSFORMS JEKYLL INTO HYDE REPRESENTS THE THIN LINE BETWEEN GOOD AND EVIL. THE TRANSFORMATION ITSELF SYMBOLIZES THE INTERNAL BATTLE THAT EXISTS WITHIN EVERY HUMAN BEING. THE SETTING OF VICTORIAN LONDON SERVES AS A BACKDROP, REFLECTING THE RIGID SOCIETAL NORMS AND EXPECTATIONS THAT JEKYLL GRAPPLES WITH.

FORESHADOWING
