INITIAL PUBLIC OFFERING AND EARLY STOCK PERFORMANCE

ACCENTURE'S JOURNEY AS A PUBLICLY TRADED COMPANY BEGAN WITH ITS INITIAL PUBLIC OFFERING (IPO) IN 2001. THE IPO MARKED A SIGNIFICANT MILESTONE FOR THE FIRM, TRANSITIONING FROM A DIVISION OF ANDERSEN CONSULTING INTO AN INDEPENDENT ENTITY LISTED ON THE NEW YORK STOCK EXCHANGE (NYSE) UNDER THE TICKER SYMBOL ACN.
