WHO NEEDS A BOAT LICENSE IN ALABAMA?

THIS REQUIREMENT APPLIES TO BOTH RESIDENTS AND NON-RESIDENTS OPERATING VESSELS ON ALABAMA WATERS. THE LAW IS INTENDED TO ENSURE YOUNGER AND LESS EXPERIENCED BOATERS ARE ADEQUATELY TRAINED TO HANDLE MOTORIZED BOATS.

ELIGIBILITY REQUIREMENTS FOR BOATING LICENSE
