UNDERSTANDING ATOMIC ASSAULTS

TYPES OF ATOMIC ASSAULTS

ATOMIC ASSAULTS CAN BE CLASSIFIED INTO SEVERAL TYPES BASED ON THE METHOD AND INTENT:

- **NUCLEAR DETONATION:** USE OF A NUCLEAR BOMB OR DEVICE TO CAUSE LARGE-SCALE DESTRUCTION.
