UNDERSTANDING THESE TYPES OF PLAGIARISM IS VITAL FOR STUDENTS AS THEY ENGAGE IN RESEARCH AND WRITING.

WHY IS PLAGIARISM A CONCERN?

PLAGIARISM UNDERMINES THE EDUCATIONAL PROCESS AND VIOLATES THE ETHICAL STANDARDS OF ACADEMIA. HERE ARE SOME REASONS WHY IT IS A SIGNIFICANT CONCERN:

ABOUT THE IU PLAGIARISM TEST

- ANSWER: NO, SELF-PLAGIARISM IS NOT ACCEPTABLE AS IT INVOLVES REUSING ONE'S OWN WORK WITHOUT PERMISSION OR ACKNOWLEDGMENT.

5. WHAT SHOULD I DO IF I ACCIDENTALLY PLAGIARIZE?

- ANSWER: IF YOU REALIZE THAT YOU HAVE PLAGIARIZED, IT IS ESSENTIAL TO ADDRESS IT IMMEDIATELY. YOU SHOULD INFORM YOUR INSTRUCTOR AND PROVIDE A CORRECTED VERSION OF YOUR WORK.

HOW TO AVOID PLAGIARISM

AVOIDING PLAGIARISM IS A FUNDAMENTAL SKILL THAT EVERY STUDENT SHOULD DEVELOP. HERE ARE SEVERAL STRATEGIES TO ENSURE ACADEMIC INTEGRITY:

1. PROPER CITATION

BEING WELL-VERSED IN VARIOUS CITATION STYLES IS CRUCIAL. HERE ARE COMMON CITATION STYLES:

- USE QUOTATION MARKS: WHENEVER YOU COPY A PHRASE DIRECTLY, USE QUOTATION MARKS AND NOTE THE SOURCE.
- SUMMARIZE AND PARAPHRASE: WHEN TAKING NOTES, SUMMARIZE OR PARAPHRASE INFORMATION IN YOUR OWN WORDS AND INCLUDE CITATIONS.

3. USE PLAGIARISM DETECTION TOOLS

BEFORE SUBMITTING ANY PAPER, CONSIDER USING PLAGIARISM DETECTION SOFTWARE. THESE TOOLS CAN HELP IDENTIFY

UNINTENTIONAL PLAGIARISM AND ENSURE THAT ALL SOURCES ARE CITED CORRECTLY. SOME POPULAR TOOLS INCLUDE:

- TURNITIN
- GRAMMARLY
- COPYSCAPE

4. UNDERSTAND THE ASSIGNMENT REQUIREMENTS

DIFFERENT ASSIGNMENTS MAY HAVE DIFFERENT REQUIREMENTS REGARDING SOURCE USE. ALWAYS CLARIFY WITH YOUR INSTRUCTOR WHAT IS EXPECTED. IF YOU'RE UNSURE, DON'T HESITATE TO ASK QUESTIONS.

5. DEVELOP YOUR VOICE

ONE EFFECTIVE WAY TO MINIMIZE THE RISK OF PLAGIARISM IS TO DEVELOP YOUR UNIQUE ACADEMIC VOICE. HERE'S HOW:

- ENGAGE WITH THE MATERIAL: READ WIDELY AND CRITICALLY TO FORM YOUR OPINIONS.
- PRACTICE WRITING: THE MORE YOU WRITE, THE MORE YOU WILL DEVELOP YOUR STYLE AND VOICE.

CONSEQUENCES OF PLAGIARISM AT IU

INDIANA UNIVERSITY TAKES PLAGIARISM SERIOUSLY, AND THE CONSEQUENCES CAN BE SEVERE. HERE ARE POTENTIAL REPERCUSSIONS:

- FAILING GRADE: STUDENTS MAY RECEIVE A FAILING GRADE FOR THE ASSIGNMENT OR COURSE.
- ACADEMIC PROBATION: REPEAT OFFENSES CAN LEAD TO PROBATIONARY STATUS.
- EXPULSION: IN SEVERE CASES, STUDENTS MAY BE EXPELLED FROM THE UNIVERSITY.

ARE THERE SPECIFIC RESOURCES PROVIDED BY IU TO HELP WITH PLAGIARISM?
