TYPES OF PROBLEMS TO INCLUDE IN THE WORKSHEET

3. REAL-WORLD APPLICATIONS

CREATE SCENARIOS THAT STUDENTS CAN RELATE TO:

- A STORE IS OFFERING A 20% DISCOUNT ON A \$50 JACKET. HOW MUCH WILL THE JACKET COST AFTER THE DISCOUNT?
- IF A MEAL COSTS \$60 AND THE TIP IS 18%, HOW MUCH WILL THE TOTAL BILL BE?
- A CAR DEPRECIATES BY 15% IN ITS FIRST YEAR. IF THE CAR WAS BOUGHT FOR \$20,000, WHAT IS ITS VALUE AFTER ONE YEAR?

4. PERCENTAGE COMPARISONS

THESE PROBLEMS ENCOURAGE STUDENTS TO COMPARE DIFFERENT PERCENTAGES:

- IF COMPANY A HAS A PROFIT MARGIN OF 30% AND COMPANY B HAS A PROFIT MARGIN OF 25%, WHICH COMPANY IS MORE PROFITABLE?
- IN A CLASS OF 30 STUDENTS, 12 ARE GIRLS. WHAT PERCENTAGE OF THE CLASS ARE GIRLS?

5. MULTI-STEP PROBLEMS

INVOLVE MULTIPLE CALCULATIONS TO SOLVE A PROBLEM:

- If a product costs \$200 and is on sale for 25% off, then there is a sales tax of 8%, what is the final price?
- A student scores 80% on a test with 50 questions. How many questions did they answer correctly?

TIPS FOR EDUCATORS ON USING APPLICATION OF PERCENTS WORKSHEETS

TO MAXIMIZE THE EFFECTIVENESS OF THESE WORKSHEETS, EDUCATORS CAN FOLLOW THESE TIPS:
