UNDERSTANDING APPLIED BEHAVIOR ANALYSIS THROUGH JOHN O. COOPER

APPLIED BEHAVIOR ANALYSIS (ABA) IS A SCIENTIFIC APPROACH FOR UNDERSTANDING AND IMPROVING HUMAN BEHAVIOR. HISTORY AND DEVELOPMENT OF ABA

THE ROOTS OF ABA CAN BE TRACED BACK TO B.F. SKINNER'S WORK IN THE MID-20TH CENTURY, WHICH LAID THE GROUNDWORK FOR UNDERSTANDING OPERANT CONDITIONING. OVER THE YEARS, BEHAVIOR ANALYSTS HAVE DEVELOPED VARIOUS TECHNIQUES AND STRATEGIES TO APPLY THESE THEORIES IN REAL-WORLD SETTINGS, PARTICULARLY IN EDUCATION AND THERAPY FOR INDIVIDUALS WITH AUTISM.
