- RESEARCH AND DEVELOPMENT
- EXPANSION EFFORTS

WITH THE ECONOMIC LANDSCAPE EVOLVING, PARTICULARLY IN THE WAKE OF THE COVID-19 PANDEMIC, ARKANSAS HAS INTRODUCED SEVERAL INITIATIVES AIMED AT SUPPORTING SMALL BUSINESS GROWTH.

TYPES OF GRANTS AVAILABLE IN ARKANSAS IN 2023

IN 2023, ARKANSAS OFFERS A VARIETY OF GRANTS TAILORED TO DIFFERENT SECTORS AND NEEDS. BELOW ARE SOME PROMINENT PROGRAMS ENTREPRENEURS SHOULD CONSIDER:

1. ARKANSAS ECONOMIC DEVELOPMENT COMMISSION (AEDC) GRANTS

- **WINROCK INTERNATIONAL:** FOCUSES ON SUSTAINABLE ECONOMIC DEVELOPMENT AND MAY OFFER GRANTS FOR BUSINESSES INVOLVED IN AGRICULTURE, RENEWABLE ENERGY, AND COMMUNITY DEVELOPMENT.
- **ARKANSAS COMMUNITY FOUNDATION:** PROVIDES GRANTS FOR VARIOUS INITIATIVES THAT ENHANCE COMMUNITY DEVELOPMENT AND SUPPORT LOCAL BUSINESSES.

ELIGIBILITY REQUIREMENTS FOR ARKANSAS SMALL BUSINESS GRANTS

WHILE EACH GRANT PROGRAM HAS ITS OWN SPECIFIC ELIGIBILITY CRITERIA, THERE ARE COMMON FACTORS THAT MOST GRANTORS CONSIDER:

1. **BUSINESS STRUCTURE:** MOST GRANTS ARE AVAILABLE FOR SMALL BUSINESSES, WHICH TYPICALLY INCLUDE SOLE PROPRIETORSHIPS, PARTNERSHIPS, AND CORPORATIONS WITH A LIMITED NUMBER OF EMPLOYEES.

3. **BUSINESS PURPOSE:** APPLICANTS MUST DEMONSTRATE THAT THEIR BUSINESS ALIGNS WITH THE PURPOSE OF THE GRANT, SUCH AS JOB CREATION OR COMMUNITY DEVELOPMENT.
4. **FINANCIAL HEALTH:** GRANTORS OFTEN REVIEW THE FINANCIAL STABILITY OF THE BUSINESS, INCLUDING REVENUE, EXPENSES, AND CREDITWORTHINESS.
5. **INNOVATION AND IMPACT:** MANY GRANTS PRIORITIZE BUSINESSES THAT OFFER INNOVATIVE PRODUCTS OR SERVICES OR DEMONSTRATE A SIGNIFICANT POSITIVE IMPACT ON THEIR COMMUNITIES.

APPLICATION PROCESS FOR GRANT FUNDING

NAVIGATING THE GRANT APPLICATION PROCESS CAN BE DAUNTING, BUT UNDERSTANDING THE STEPS CAN HELP STREAMLINE YOUR EFFORTS. HERE IS A GENERAL GUIDE TO APPLYING FOR SMALL BUSINESS GRANTS IN ARKANSAS:

1. RESEARCH AVAILABLE GRANTS

START BY RESEARCHING VARIOUS GRANT PROGRAMS TO IDENTIFY THOSE THAT ALIGN WITH YOUR BUSINESS NEEDS. UTILIZE RESOURCES SUCH AS:

- STATE ECONOMIC DEVELOPMENT WEBSITES
- THE SBA WEBSITE

- LOCAL CHAMBERS OF COMMERCE

2. PREPARE REQUIRED DOCUMENTATION

MOST GRANT APPLICATIONS REQUIRE SPECIFIC DOCUMENTATION, INCLUDING:

- BUSINESS PLAN: A COMPREHENSIVE OVERVIEW OF YOUR BUSINESS MODEL, MARKET ANALYSIS, AND GROWTH STRATEGY.
- FINANCIAL STATEMENTS: RECENT FINANCIAL STATEMENTS, INCLUDING BALANCE SHEETS AND INCOME STATEMENTS.
- TAX RETURNS: PERSONAL AND BUSINESS TAX RETURNS FOR THE PAST FEW YEARS.
- PROJECT PROPOSAL: A DETAILED DESCRIPTION OF HOW THE GRANT FUNDS WILL BE USED AND THE EXPECTED IMPACT.

3. COMPLETE THE APPLICATION

FOLLOW THE SPECIFIC INSTRUCTIONS PROVIDED BY THE GRANTOR TO FILL OUT THE APPLICATION ACCURATELY. PAY ATTENTION TO DETAILS AND ENSURE THAT ALL REQUIRED DOCUMENTS ARE SUBMITTED.

4. SUBMIT AND FOLLOW UP

AFTER SUBMITTING YOUR APPLICATION, FOLLOW UP WITH THE GRANTOR TO CONFIRM RECEIPT AND INQUIRE ABOUT THE TIMELINE FOR DECISION-MAKING.

MAXIMIZING YOUR CHANCES OF SECURING FUNDING

2. DEMONSTRATE CLEAR IMPACT

SHOWCASE HOW YOUR BUSINESS WILL POSITIVELY IMPACT THE LOCAL ECONOMY, CREATE JOBS, OR ADDRESS COMMUNITY NEEDS. USE CONCRETE DATA AND CASE STUDIES TO STRENGTHEN YOUR ARGUMENT.

3. GATHER STRONG RECOMMENDATIONS

INCLUDE LETTERS OF RECOMMENDATION FROM COMMUNITY LEADERS, INDUSTRY EXPERTS, OR PREVIOUS PARTNERS TO BOLSTER YOUR CREDIBILITY AND DEMONSTRATE SUPPORT FOR YOUR BUSINESS.

4. PREPARE FOR INTERVIEWS

SOME GRANT PROGRAMS MAY REQUIRE INTERVIEWS AS PART OF THE SELECTION PROCESS. PRACTICE ARTICULATING YOUR BUSINESS VISION, GOALS, AND HOW THE GRANT WILL FACILITATE YOUR PLANS.

WHAT TYPES OF SMALL BUSINESS GRANTS ARE AVAILABLE IN ARKANSAS FOR 2023?
