THE CONCEPT OF ASYLUM IS ROOTED IN INTERNATIONAL LAW AND IS RECOGNIZED BY MANY COUNTRIES WORLDWIDE. WHAT CONSTITUTES ELIGIBILITY FOR ASYLUM?

WHO IS TYPICALLY NOT ELIGIBLE FOR ASYLUM?

CERTAIN INDIVIDUALS ARE INELIGIBLE FOR ASYLUM, INCLUDING THOSE WHO HAVE COMMITTED SERIOUS CRIMES, POSE A SECURITY THREAT, OR HAVE BEEN PREVIOUSLY DENIED ASYLUM. ADDITIONALLY, PEOPLE WHO HAVE BEEN FIRMLY RESETTLED IN ANOTHER COUNTRY OR WHO HAVE VOLUNTARILY RETURNED TO THEIR HOME COUNTRY AFTER FLEEING MAY NOT QUALIFY. THE ASYLUM APPLICATION PROCESS

THE ASYLUM APPLICATION PROCESS INVOLVES SEVERAL CRITICAL STEPS THAT MUST BE FOLLOWED CAREFULLY TO ENSURE

Rights and Responsibilities of Asylum Seekers

WHAT IS THE DIFFERENCE BETWEEN ASYLUM AND REFUGEE STATUS?

ASYLUM IS PROTECTION GRANTED TO INDIVIDUALS WHO ARE ALREADY PRESENT IN THE COUNTRY WHERE THEY SEEK SAFETY OR AT ITS BORDER, WHILE REFUGEE STATUS IS TYPICALLY GRANTED TO INDIVIDUALS OUTSIDE THEIR HOME COUNTRY AND OUTSIDE THE COUNTRY OF ASYLUM, OFTEN THROUGH UNHCR REFERRALS OR RESETTLEMENT PROGRAMS.
