- TRUE OR FALSE: ASPIRIN SHOULD NOT BE GIVEN TO CHILDREN DUE TO THE RISK OF REYE'S SYNDROME.

FILL IN THE BLANKS

THESE QUESTIONS REQUIRE THE TEST TAKER TO PROVIDE THE CORRECT WORD OR PHRASE TO COMPLETE A STATEMENT. FOR INSTANCE:

- THE PRIMARY SIDE EFFECT OF _____ IS SEDATION.

CASE STUDIES

IN MORE ADVANCED TESTS, HEALTHCARE PROFESSIONALS MAY BE PRESENTED WITH CASE STUDIES THAT REQUIRE THEM TO APPLY THEIR KNOWLEDGE TO REAL-WORLD SCENARIOS. THIS MAY INCLUDE:

- ANALYZING A PATIENT'S MEDICATION REGIMEN.

- CONSIDER DOWNLOADING APPS DESIGNED FOR HEALTHCARE PROFESSIONALS THAT PROVIDE QUICK ACCESS TO DRUG INFORMATION, INTERACTIONS, AND DOSING GUIDELINES.

COMMON MEDICATION ERRORS AND PREVENTION STRATEGIES

- ILLEGIBLE PRESCRIPTIONS: MISINTERPRETATION OF A PHYSICIAN'S HANDWRITING LEADING TO DISPENSING ERRORS.

PREVENTION STRATEGIES

- DOUBLE-CHECK MEDICATIONS: ALWAYS VERIFY THE MEDICATION AND DOSAGE BEFORE ADMINISTRATION.
- USE TECHNOLOGY: EMPLOY ELECTRONIC HEALTH RECORDS (EHRs) AND COMPUTERIZED PHYSICIAN ORDER ENTRY (CPOE) SYSTEMS TO MINIMIZE HUMAN ERROR.
