LESSONS FROM BAD CHAD'S STORY

BAD CHAD'S DRUG HISTORY SERVES AS A POWERFUL REMINDER OF THE COMPLEXITIES OF ADDICTION AND RECOVERY. IT HIGHLIGHTS SEVERAL ESSENTIAL LESSONS:

1. THE IMPORTANCE OF SUPPORT: COMMUNITY AND FAMILIAL SUPPORT ARE CRUCIAL IN THE RECOVERY PROCESS.
