KEY THEMES IN "BEHIND THE GREEN MASK"

KOIRE'S BOOK IS STRUCTURED AROUND SEVERAL KEY THEMES THAT ILLUSTRATE HER ARGUMENTS AGAINST THE PREVAILING NARRATIVE SURROUNDING SUSTAINABLE DEVELOPMENT.

1. AGENDA 21: THE FRAMEWORK FOR CONTROL

ONE OF THE CENTRAL CONCEPTS IN THE BOOK IS THE IDEA OF AGENDA 21, A NON-BINDING ACTION PLAN DEVISED BY THE UNITED NATIONS DURING THE EARTH SUMMIT IN 1992.
