 - C. FEDERALISM
 - D. INDIVIDUAL RIGHTS

THIS STRUCTURE HELPS IN SYSTEMATICALLY COVERING ALL NECESSARY ASPECTS OF EACH SUBJECT AREA.

4. INCORPORATE RULES AND FRAMEWORKS

EACH LEGAL AREA HAS SPECIFIC RULES AND FRAMEWORKS THAT ARE VITAL FOR THE EXAM. IT IS CRUCIAL TO INCLUDE:

- KEY LEGAL PRINCIPLES
- STATUTES AND RELEVANT CASE LAW
- TESTS AND STANDARDS (E.G., STRICT SCRUTINY, BALANCING TESTS)

- NEGLECTING UPDATES: AS YOU PROGRESS IN YOUR STUDIES, FAILING TO UPDATE YOUR OUTLINES CAN LEAD TO OUTDATED INFORMATION.
- RELYING SOLELY ON OUTLINES: WHILE OUTLINES ARE CRUCIAL, THEY SHOULD NOT BE THE ONLY STUDY TOOL. SUPPLEMENT THEM WITH PRACTICE EXAMS, LECTURES, AND OTHER RESOURCES.

ADDITIONAL RESOURCES FOR BAR EXAM PREPARATION
