THIS DISTINCTIVENESS ALLOWS FORENSIC EXPERTS TO RELY ON FINGERPRINT COMPARISON AS A DEFINITIVE IDENTIFICATION METHOD IN CRIMINAL CASES.

THE ROLE OF FINGERPRINTS IN LEGAL EVIDENCE

WHORL FINGERPRINTS

WHORLS CONSIST OF CIRCULAR OR SPIRAL RIDGES. THESE PATTERNS ARE LESS COMMON THAN LOOPS BUT PROVIDE STRONG IDENTIFICATION MARKERS DUE TO THEIR COMPLEX STRUCTURE. WHORLS INCLUDE PLAIN WHORLS, CENTRAL POCKET LOOPS, DOUBLE LOOPS, AND ACCIDENTAL WHORLS.

ARCH FINGERPRINTS

ARCH PATTERNS ARE THE LEAST COMMON AND FEATURE RIDGES THAT ENTER FROM ONE SIDE AND EXIT THE OTHER SIDE IN A WAVE-LIKE FASHION. ARCHES ARE DIVIDED INTO PLAIN ARCHES AND TENTED ARCHES BASED ON THEIR SHAPE.

TECHNIQUES FOR COLLECTING FINGERPRINTS AT CRIME SCENES

ALTERNATE LIGHT SOURCES

- SECURE AND DOCUMENT THE CRIME SCENE THOROUGHLY.
- SELECT APPROPRIATE FINGERPRINT POWDER OR CHEMICAL BASED ON SURFACE TYPE.
- APPLY POWDER OR CHEMICAL CAREFULLY TO AVOID DAMAGING PRINTS.
- USE LIFTING TAPE OR PHOTOGRAPHY TO PRESERVE THE DEVELOPED FINGERPRINTS.
- LABEL AND STORE FINGERPRINT EVIDENCE PROPERLY FOR ANALYSIS.
