TO DRIVE A BUS OR TRANSPORT PASSENGERS, DRIVERS MUST OBTAIN A PASSENGER ENDORSEMENT (P) IN ADDITION TO THEIR CLASS B LICENSE. THIS ENDORSEMENT SIGNIFIES THAT THE DRIVER HAS MET THE SPECIFIC REQUIREMENTS AND POSSESSES THE NECESSARY KNOWLEDGE AND SKILLS TO OPERATE A PASSENGER VEHICLE SAFELY.

IMPORTANCE OF THE PASSENGER ENDORSEMENT

THE PASSENGER ENDORSEMENT IS CRITICAL FOR SEVERAL REASONS:
