ORIGINS OF THE TWO-PARTY SYSTEM IN AMERICA

THESE IDEOLOGICAL CONFLICTS LAID THE FOUNDATION FOR THE FIRST AMERICAN POLITICAL PARTIES AND ESTABLISHED THE PATTERN OF POLITICAL COMPETITION THAT ENDURES TODAY.

THE FEDERALIST PARTY

THE FEDERALIST PARTY WAS THE FIRST POLITICAL PARTY IN THE UNITED STATES, EMPHASIZING A STRONG NATIONAL GOVERNMENT TO ENSURE STABILITY AND ECONOMIC GROWTH. THE DEMOCRATIC-REPUBLICAN PARTY

IN CONTRAST, THE DEMOCRATIC-REPUBLICAN PARTY EMERGED TO COUNTER THE FEDERALISTS' VISION BY ADVOCATING LIMITED FEDERAL GOVERNMENT POWER AND GREATER EMPHASIS ON AGRARIANISM AND INDIVIDUAL LIBERTIES. THIS PARTY WAS INSTRUMENTAL IN PROMOTING THE JEFFERSONIAN IDEAL OF A REPUBLIC GOVERNED BY THE PEOPLE, WITH POWER DECENTRALIZED TO THE STATES. THEIR OPPOSITION TO THE FINANCIAL POLICIES OF THE FEDERALISTS HELPED GALVANIZE SUPPORT AMONG

FARMERS AND RURAL POPULATIONS.

THE WHIGS REPRESENTED BUSINESS INTERESTS AND URBAN CONSTITUENCIES.

THE REPUBLICAN PARTY AND ITS EMERGENCE

THE REPUBLICAN PARTY WAS FOUNDED IN THE 1850S, PRIMARILY IN OPPOSITION TO THE SPREAD OF SLAVERY INTO WESTERN TERRITORIES. IT QUICKLY SUPPLANTED THE WHIGS AS THE MAIN RIVAL TO THE DEMOCRATS. THE REPUBLICANS STOOD FOR THE PRESERVATION OF THE UNION, ABOLITION OF SLAVERY, AND PROMOTION OF INDUSTRIAL DEVELOPMENT.
