# KEY PARTICIPANTS AND THEIR OBJECTIVES

THE CONGRESS OF VIENNA BROUGHT TOGETHER DIPLOMATS AND MONARCHS FROM ACROSS EUROPE, EACH REPRESENTING THEIR NATION'S INTERESTS. - **RUSSIA:** REPRESENTED BY TSAR ALEXANDER I, RUSSIA PURSUED TERRITORIAL EXPANSION, PARTICULARLY INTO POLAND AND FINLAND, WHILE PROMOTING A CONSERVATIVE ORDER.
- **PRUSSIA:** FOCUSED ON TERRITORIAL GAINS IN WESTERN GERMANY AND STRENGTHENING ITS POSITION WITHIN THE GERMAN CONFEDERATION.
- **GREAT BRITAIN:** CONCENTRATED ON MAINTAINING NAVAL SUPREMACY AND PREVENTING ANY SINGLE POWER FROM DOMINATING THE CONTINENT.
- **FRANCE:** ALTHOUGH RECENTLY DEFEATED, FRANCE, UNDER CHARLES MAURICE DE TALLEYRAND, SOUGHT TO REESTABLISH ITSELF AS A MAJOR EUROPEAN POWER THROUGH DIPLOMATIC NEGOTIATION.

## DIPLOMATIC STRATEGIES

EACH PARTICIPANT USED DIPLOMACY TO ADVANCE NATIONAL INTERESTS WHILE COOPERATING ON SHARED GOALS. METTERNICH'S CONSERVATIVE VISION HEAVILY INFLUENCED THE CONGRESS, ADVOCATING FOR A BALANCE OF POWER AND LEGITIMACY. MEANWHILE, TALLEYRAND'S SKILLFUL NEGOTIATION ENSURED FRANCE REMAINED PART OF THE EUROPEAN ORDER DESPITE ITS RECENT DEFEAT.

## MAIN PRINCIPLES AND AGREEMENTS

5. ESTABLISHMENT OF THE GERMAN CONFEDERATION, A LOOSE ASSOCIATION OF 39 GERMAN STATES REPLACING THE DISSOLVED HOLY ROMAN EMPIRE.

## POLITICAL OUTCOMES

THE CONGRESS'S DECISIONS REINFORCED CONSERVATIVE REGIMES AND SUPPRESSED NATIONALIST AND LIBERAL MOVEMENTS.
