## HISTORICAL CONTEXT

THE IDEA OF CHECKS AND BALANCES HAS ITS ROOTS IN ENLIGHTENMENT PHILOSOPHY, PARTICULARLY IN THE WORKS OF THINKERS LIKE MONTESQUIEU, WHO ADVOCATED FOR THE SEPARATION OF POWERS. ## THE THREE BRANCHES OF GOVERNMENT

- VETOING LEGISLATION
- APPOINTING FEDERAL JUDGES
- CONDUCTING FOREIGN POLICY

2. LEGISLATIVE BRANCH: COMPRISING THE HOUSE OF REPRESENTATIVES AND THE SENATE, THE LEGISLATIVE BRANCH CREATES LAWS. ITS POWERS INCLUDE:

- MAKING LAWS
- CONTROLLING BUDGET AND APPROPRIATIONS

3. JUDICIAL BRANCH: THIS BRANCH INTERPRETS LAWS AND ADMINISTERS JUSTICE. IT INCLUDES:

- THE SUPREME COURT AND LOWER FEDERAL COURTS
- THE POWER OF JUDICIAL REVIEW TO DECLARE LAWS OR EXECUTIVE ACTIONS UNCONSTITUTIONAL

## THE MECHANISMS OF CHECKS AND BALANCES

THE SYSTEM OF CHECKS AND BALANCES OPERATES THROUGH VARIOUS MECHANISMS, ENSURING THAT EACH BRANCH CAN MONITOR AND LIMIT THE POWERS OF THE OTHERS. HERE ARE KEY EXAMPLES:

- PARDON POWER: THE PRESIDENT CAN GRANT PARDONS, WHICH CAN CHECK JUDICIAL DECISIONS.

## CHECKS BY THE JUDICIAL BRANCH

- JUDICIAL REVIEW: THE COURTS HAVE THE AUTHORITY TO INTERPRET LAWS AND CAN DECLARE LEGISLATION OR EXECUTIVE ACTIONS UNCONSTITUTIONAL.
- LIFETIME APPOINTMENTS: FEDERAL JUDGES SERVE FOR LIFE, INSULATING THEM FROM POLITICAL PRESSURES AND ALLOWING THEM TO UPHOLD THE CONSTITUTION WITHOUT FEAR OF REPRISAL.
