- **MAIL REQUESTS:** FOR THOSE UNABLE TO ACCESS RECORDS IN PERSON, MAIL REQUESTS CAN BE SUBMITTED. IT IS IMPORTANT TO INCLUDE ADEQUATE INFORMATION ABOUT THE CASE, SUCH AS THE NAMES OF THE PARTIES INVOLVED AND THE CASE NUMBER IF KNOWN.
- **THIRD-PARTY SERVICES:** SEVERAL THIRD-PARTY WEBSITES AND SERVICES OFFER ACCESS TO COURT RECORDS FOR A FEE. HOWEVER, IT IS ADVISABLE TO USE CAUTION AND VERIFY THE LEGITIMACY OF THESE SOURCES, AS THEY MAY NOT ALWAYS PROVIDE ACCURATE OR UP-TO-DATE INFORMATION.

## Cost of Accessing Court Records
