TO OBTAIN A CLASS C CDL, YOU MUST PASS BOTH A WRITTEN KNOWLEDGE TEST AND A DRIVING SKILLS TEST SPECIFIC TO THE VEHICLE YOU WILL BE OPERATING.

THE IMPORTANCE OF CLASS C CDL PRACTICE TESTS
