3. **DEPTH AND CLARITY:** DEPTH PLAYS A SIGNIFICANT ROLE IN WATER COLOR. IN DEEP WATER, BLUE WAVELENGTHS ARE ABSORBED LESS THAN RED WAVELENGTHS, MAKING DEEPER WATER APPEAR BLUER. CONVERSELY, SHALLOWER WATERS OFTEN TAKE ON COLORS FROM THE MATERIALS BENEATH THEM, SUCH AS SAND, MUD, OR VEGETATION.

FACTORS INFLUENCING WATER COLOR

SEVERAL FACTORS CAN INFLUENCE THE COLOR OF WATER IN LAKES, RIVERS, AND OCEANS, INCLUDING:

1. NATURAL ELEMENTS

- **ALGAE AND PHYTOPLANKTON:** PRESENCE OF ALGAE CAN CAUSE WATER TO APPEAR GREEN OR BROWN DUE TO PIGMENTS LIKE CHLOROPHYLL. IN LARGE BLOOMS, THESE ORGANISMS CAN DRASTICALLY ALTER THE COLOR OF THE WATER.

2. CHEMICAL INFLUENCES

- **POLLUTANTS:** INDUSTRIAL WASTE, AGRICULTURAL RUNOFF, AND SEWAGE CAN INTRODUCE HARMFUL CHEMICALS THAT CHANGE THE COLOR OF WATER. FOR EXAMPLE, HEAVY METALS CAN CREATE DISCOLORATION.

- **LOWLAND RIVERS:** MAY APPEAR BROWN OR MURKY, ESPECIALLY AFTER HEAVY RAINFALL OR FLOODING, DUE TO HIGH SEDIMENT LOADS.

HUMAN IMPACT ON WATER COLOR

1. POLLUTION
