PURPOSE OF THE COLORADO CHILD SUPPORT WORKSHEET A

- SOCIAL SECURITY NUMBERS
- EMPLOYMENT INFORMATION

STEP 3: REPORT INCOME

NEXT, YOU WILL REPORT THE GROSS MONTHLY INCOME FOR BOTH PARENTS. THIS SECTION WILL REQUIRE YOU TO DETAIL:

- WAGES AND SALARIES
- SELF-EMPLOYMENT INCOME
- RENTAL INCOME
- INVESTMENT INCOME
- OTHER INCOME SOURCES

MAKE SURE TO DOCUMENT ALL SOURCES OF INCOME ACCURATELY, AS THIS WILL AFFECT THE FINAL CALCULATION.

STEP 4: ACCOUNT FOR DEDUCTIONS

THERE ARE SPECIFIC DEDUCTIONS THAT CAN BE SUBTRACTED FROM GROSS INCOME, SUCH AS:

- MANDATORY RETIREMENT CONTRIBUTIONS
- HEALTH INSURANCE PREMIUMS FOR THE CHILDREN
- CHILD CARE EXPENSES NECESSARY FOR EMPLOYMENT

BE PRECISE IN LISTING THESE DEDUCTIONS, AS THEY CAN SIGNIFICANTLY IMPACT THE FINAL CHILD SUPPORT AMOUNT.

STEP 5: CALCULATE BASIC CHILD SUPPORT OBLIGATION

ONCE YOU HAVE INPUT ALL RELEVANT INCOME AND DEDUCTIONS, YOU WILL CALCULATE THE BASIC CHILD SUPPORT OBLIGATION USING THE COLORADO CHILD SUPPORT GUIDELINES. THIS INVOLVES:

1. DETERMINING THE COMBINED MONTHLY ADJUSTED GROSS INCOME (AGI) OF BOTH PARENTS.

FACTORS CONSIDERED IN CHILD SUPPORT CALCULATIONS

4. OTHER CHILDREN

IF EITHER PARENT HAS OTHER CHILDREN FOR WHOM THEY ARE PROVIDING SUPPORT, THIS MAY IMPACT THE CHILD SUPPORT CALCULATION.

COMMON FAQs ABOUT COLORADO CHILD SUPPORT WORKSHEET A

1. DO I NEED A LAWYER TO FILL OUT THE WORKSHEET?

3. CAN I APPLY FOR CHILD SUPPORT WITHOUT A LEGAL SEPARATION OR DIVORCE?

YES, YOU CAN APPLY FOR CHILD SUPPORT THROUGH THE COURTS REGARDLESS OF YOUR MARITAL STATUS, AS LONG AS PATERNITY IS ESTABLISHED.

4. HOW OFTEN IS CHILD SUPPORT REVIEWED?

CHILD SUPPORT ORDERS CAN BE REVIEWED AND MODIFIED AS NECESSARY, TYPICALLY EVERY THREE YEARS, OR IF THERE IS A SUBSTANTIAL CHANGE IN CIRCUMSTANCES.
