2. ETHICAL GUIDELINES

- NATIONAL ASSOCIATION OF SOCIAL WORKERS (NASW) CODE OF ETHICS: FOR SOCIAL WORKERS, THIS CODE OUTLINES ETHICAL RESPONSIBILITIES TO CLIENTS, COLLEAGUES, AND THE BROADER COMMUNITY.
- COLORADO-SPECIFIC ETHICAL GUIDELINES: EACH PROFESSION MAY HAVE SPECIFIC ETHICAL STANDARDS SET BY THEIR RESPECTIVE LICENSING BOARDS.

3. CLIENT RIGHTS AND CONFIDENTIALITY

UNDERSTANDING CLIENT RIGHTS AND CONFIDENTIALITY IS ESSENTIAL FOR ANY MENTAL HEALTH PROFESSIONAL. KEY TOPICS INCLUDE:

- **INFORMED CONSENT:** CLIENTS MUST BE INFORMED ABOUT THE NATURE OF THERAPY, INCLUDING THE RISKS AND BENEFITS, AND PROVIDE CONSENT BEFORE TREATMENT BEGINS.

4. SCOPE OF PRACTICE

EACH MENTAL HEALTH PROFESSION HAS A DEFINED SCOPE OF PRACTICE. UNDERSTANDING THESE BOUNDARIES IS CRUCIAL FOR ETHICAL AND LEGAL COMPLIANCE:

- **ROLE OF PSYCHOLOGISTS:** PSYCHOLOGISTS TYPICALLY PROVIDE ASSESSMENT, DIAGNOSIS, AND THERAPY, AND CAN OFFER PSYCHOLOGICAL TESTING.
- **ROLE OF COUNSELORS:** LPCs FOCUS ON PROVIDING COUNSELING SERVICES, OFTEN WITH SPECIFIC POPULATIONS OR ISSUES, SUCH AS MARRIAGE AND FAMILY THERAPY.
- **ROLE OF SOCIAL WORKERS:** SOCIAL WORKERS MAY PROVIDE THERAPY BUT ARE ALSO INVOLVED IN CASE MANAGEMENT AND ADVOCACY, EMPHASIZING SOCIAL JUSTICE AND COMMUNITY RESOURCES.
