CORRECTIONAL OFFICER PRE-EMPLOYMENT MEDICAL EXAM

2. PHYSICAL EXAMINATION

4. MENTAL HEALTH DISORDERS: ASSESSING FOR ISSUES LIKE ANXIETY, DEPRESSION, OR PTSD IS CRUCIAL, AS THESE CAN IMPACT DECISION-MAKING AND STRESS MANAGEMENT.

PREPARING FOR THE PRE-EMPLOYMENT MEDICAL EXAM
