6. STAY CALM AND CONFIDENT

ON THE DAY OF THE TEST, ENSURE YOU ARE RELAXED. A CALM MINDSET CAN IMPROVE YOUR ABILITY TO RECALL INFORMATION AND THINK CRITICALLY DURING THE EXAM.
